<u>Creditable Coverage Disclosure Notice for Medicare Eligible Members</u></u>

Important Notice for <u>MEDICARE ELIGIBLE</u> members from MAYFLOWER MUNICIPAL HEALTH GROUP (MMHG) about your Prescription Drug Coverage and Medicare

THIS NOTICE IS FOR MEDICARE ELIGIBLE SUBSCRIBERS AND/OR MEDICARE ELIGIBLE <u>DEPENDENT(S) ONLY</u>. Please disregard this notice if the MMHG health insurance subscriber and dependent(s) are <u>not</u> Medicare eligible.

<u>Please read this notice carefully and keep it where you can find it</u>. This notice has information about your current prescription drug coverage with one of the following towns/governmental units that are part of the MMHG; Brockton Area Transit Authority, Carver Marion RRDD, Dartmouth Fire District No. 3, Greater Attleboro Taunton Regional Transit Authority, Greater New Bedford RRMD; Towns of : Bridgewater, Halifax, Hanover, Hanson, Hull, Kingston, Marshfield, Pembroke, Plympton, Rochester, Wareham, West Bridgewater, Whitman; Norfolk County, North River Collaborative, Onset Fire District, Plymouth County, Plymouth County Retirement Association, Silver Lake Regional School District, Southeastern Regional Transit Authority, Southfield Redevelopment Authority, South Shore Educational Collaborative, South Shore Emergency 911, South Shore Regional Vocational Technical High School, Wareham Fire District, Whitman-Hanson Regional School District.

There are two important things you need to know about your current coverage and Medicare's Prescription drug coverage:

- 1. Medicare prescription drug coverage became available in 2006 to everyone with Medicare. All Medicare drug plans provide at least a standard level of coverage set by Medicare. Some plans may also offer more coverage for a higher monthly premium.
- 2. Mayflower Municipal Health Group has determined that the prescription drug coverage is, on average for all plan participants, expected to pay out as much as standard Medicare prescription drug coverage pays and is therefore considered Creditable Coverage. Because your existing coverage is Creditable Coverage, you can keep this coverage and not pay a higher premium (a penalty) if you later decide to join a Medicare drug plan.

When Can You Join A Medicare Drug Plan?

You can join a Medicare drug plan when you first become eligible for Medicare and each year from October 15th through December 7th.

However, if you lose your current creditable prescription drug coverage, through no fault of your own, you will also be eligible for a two (2) month Special Enrollment Period (SEP) to join a Medicare drug plan.

What Happens To Your Current Coverage If You Decide to Join A Medicare Drug Plan? Please keep in mind that if you plan to continue to be covered under the Mayflower Municipal Health Group's health insurance plans, you do NOT need to purchase Medicare Part D.

If you decide to join a Medicare drug plan, your current <u>active</u> plan Mayflower Municipal Health Group coverage will not be affected. However, as an enrollee you would likely have more prescription drug coverage than is needed. <u>Retirees</u> on Mayflower Municipal Health Group's part D plan(s) will lose their employer sponsored plan and will not be able to reenroll until the next open enrollment period.

If you do decide to join a Medicare drug plan and drop your current Mayflower Municipal Health Group coverage, be aware that you and your dependents will only be able to get this coverage back at the next open enrollment period if allowed by your governmental unit.

Please inform us as soon as possible if you enroll in Part D.

When Will You Pay A Higher Premium (Penalty) To Join A Medicare Drug Plan?

You should also know that if you drop or lose your current coverage with Mayflower Municipal Health Group and don't join a Medicare drug plan within 63 continuous days after your current coverage ends, you may pay a higher premium (a penalty) to join a Medicare drug plan later.
