Are there services covered before you meet your deductible? This plan covers some items and services even if you haven't yet met the deductible amount. But, a copayment or coinsurance may apply. You will pay the most if you use an out-of-network provider, and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance-billing). Does this plan meet the Minimum Value Standard? Yes
